If you make a deposit or full payment on a tour with *XTC Tours* you hereby agree to accept the terms and conditions of this contract.

ITINERARY AND RATES subject to change without notice. Price is that which is in effect as of 11/06/2011 and is based on using both three bedroom condos and two bedroom condos. Private transfers, any group activities and parties are contingent on a minimum group of 25 skiers/boarders participating.

RESERVATIONS REQUIRE a per person deposit of \$250.00 to confirm the reservation. **All package reservation requests are tentative till confirmed by XTC Tours.** Full payment is due no later than December 16, 2011. Reservations made after December 16, 2011, if space is available, require full payment. All payments made after December 16, 2011 are non-refundable subject to the cancellation penalties outlined below. **FINAL PAYMENTS NOT RECEIVED BY December 16, 2011 ARE SUBJECT TO A \$50.00 PER PERSON LATE FEE!**

CANCELLATIONS must be received in writing. **ALL CANCELLATIONS ARE SUBJECT TO A \$100.00 PER PERSON HANDLING FEE AND any fees charged by suppliers and the airlines.** Cancellations received before December 16, 2011 will be charged **\$100.00 AND** any fees charged by suppliers and the airlines. Cancellations received after December 16, 2011 are not refundable unless the opening can be filled and there will still be penalties charged by suppliers and the airlines. There is no refund for any unused services. *XTC Tours* reserves the right to cancel the tour any time prior to departure and is only liable to refund all monies paid by passengers.
